
• Standard 6: *Technical Services*

Every school adheres to the District library standards related to the cataloging, processing, labeling, and arrangement of books.


MANAGEMENT & OPERATION

- Books are shelved in FIC, SC, 000-999, Ref, and P order
- All books (other languages, AR or Lexile, Special collections) are interfiled into one standard library order
- Books are cataloged, processed, and labeled according to LAUSD specifications
- The LMC walls, sections, and shelves are properly labeled

Please note:

- The proper procedure is to capitalize <u>only</u> the first letter of the author's last name
- When there is no author, use the first three letters of the title
- For Language labels please use the designated labels. It is <u>not</u> acceptable cataloging to add the language on the Call Number spine label


Sample call numbers for pulled-out sections:
